2023 RATES AND 4TH QUARTER BILLING The Dillon Valley District bills quarterly and in arrears. This billing is for the 4th quarter 2023 – Oct 1st through Dec 31st. District Administration typically sends out statements within 2 weeks following the end of any given quarter.

2024 USER RATES The Dillon Valley Board of Directors voted to approve the 2024 rates shown below at a regular board meeting on November 16, 2023. Notices that 2024 rates were going to be discussed were posted on the district website and information was sent out in the 3rd quarter newsletter included with customer statements.

The 2024 user rates are in effect as of January 1, 2024 and will be reflected in the 1st quarter billing in early April. The rate increase is required to cover increasing costs in operations and repairs, and to continue to build reserve funds for water and sewer line improvements. The approximate quarterly increase for most users is 6.0%.

Sewer Backups All property owners should review information regarding items to avoid flushing into the toilet and the effects of a sewer line backup. The information is on the website www.dillonvalleymetro.com

As a reminder, your water and sewer service lines are the responsibility of the property owner regarding maintenance and liability. You may want to review your homeowners insurance for coverage options.

To avoid problems with your sewer service lines, and the main lines of the District, remember toilets are for a specific use and should not be used as a trash can.

Even products that appear to be or are indicated to be flushable have caused sewer blockage problems. Examples are baby wipes and other non-biodegradable items.

FROZEN PIPES During the cold months owners should make sure that their home has sufficient heat to avoid freezing your water pipes inside the house. This applies mostly to homes NOT occupied fulltime, but also can apply to unused areas of your home with water pipes including utility rooms, basements, and crawlspaces. Your water meter must be protected from freezing. The District monitors unusual water usage, but in the event of a broken pipe, generally major damage would have already occurred by the time the usage from the break is recognized by the meter reading system.
